Where Do the Candidates Stand on Life? Mark Ronchetti **Ben Ray Luján**

Abortion on Demand

There have been 61 million abortions since the 1973 Roe v. Wade Supreme Court decision legalized abortion on demand.

Mark Ronchetti is pro-life. He opposes abortion on demand, and he supports protection for unborn children.

Ben Ray Luján supports a policy of abortion on demand, which allows abortion for any reason.

Ben Ray Luján is a co-sponsor of HR 2975, a bill that, if enacted, would invalidate nearly all state and federal limitations on abortion.

Pain-Capable Unborn Child Protection Act

The Pain-Capable Unborn Child Protection Act would protect unborn children by prohibiting abortion at 20 weeks, a point by which the unborn child is capable of experiencing great pain when being killed by dismemberment or other late abortion methods.

Mark Ronchetti supports a bill that would prohibit abortions after 20 weeks when the unborn child can feel pain.

Ben Ray Luján voted against legislation that would protect unborn children from abortion after 20 weeks when the unborn child can feel pain.

Born-Alive Abortion Survivors Protection Act

The Born-Alive Abortion Survivors Protection Act would require that a baby born alive during an abortion be afforded the same degree of care that would apply to any other baby delivered at the same gestational age.

Mark Ronchetti supports the Born-Alive Abortion Survivors Protection Act.

Ben Ray Luján voted against the Born-Alive Abortion Survivors Protection Act.

Taxpayer Funding of Abortion

Prohibiting taxpayer funding of abortion saves lives.

Mark Ronchetti opposes the use of our tax dollars for abortion. He also opposes taxpayer funding of abortion providers.

Ben Ray Luján voted to allow the use of our tax dollars for abortion. He also voted for taxpayer funding of abortion providers.

Judicial Nominations to the US Supreme Court

The fundamental documents of American democracy and freedom, the Constitution and the Declaration of Indepencence, have given us essential principles to be respected by the courts such as the "unalienable" right to life. The next president may have the opportunity to appoint one to three justices to the U.S. Supreme Court.

Mark Ronchetti supports confirmation to the U.S. Supreme Court of well-qualified persons such as Brett Kavanaugh, who voted this year to uphold Louisiana's pro-life law.

Ben Ray Luján opposed confirmation of Justice Brett Kavanaugh to the U.S. Supreme Court.
